## RECALL PETITION SERVED TO YSPUC DIRECTORS On 12/10/2024



#### STEPS of a RECALL PETITION FOR YSPUC

- YLOA Board of Directors held Executive Session to discuss and vote on YSPUC Recall Petition. (12/10/2024)
- 2. After Vote, YSPUC Directors were notified of the Petition for Recall of ALL YSPUC Directors. (12/10/2024)
- 3. YSPUC needed to provide a Special Meeting Date for the Recall Election and notify the YLOA Board of a Special Meeting within (20) days from the notification date of 12/10/2024.
- 4. Recall Election was to be set between 35 days and 90 days from the receipt of the petition request.
- 5. A Special Meeting would have needed to be held by YSPUC for the YLOA Directors to vote Yes or No to the recall petition that was submitted.
- 6. If Yes to YSPUC Recall, all existing YSPUC Directors would be removed. The YLOA Board would appoint the new YSPUC Directors at that time. If No to YSPUC Recall, then the YSPUC board would stand.
- 7. On December 10, 2024, all YSPUC Directors, except for one director, resigned at the open session and gave reasons during the meeting. Then Ken Sartain turned the meeting over to Cheryl Bluhm to adjourn as the sole remaining Director of YSPUC. Then the YSPUC Directors that resigned, turned to online social media and provided additional written reasons on why they resigned.

Because of a YLOA Executive session decision on 1/6/2025, YSPUC was notified that the Recall Petition had been voted to be withdrawn considering the (5) YSPUC directors who resigned at the YSPUC Open Session on 12/10/2024.

## YSPUC Bylaws

Section 4. VACANCIES. Vacancies in the Board of Directors may be filled by a majority of the remaining directors; though less than a quorum, or by a sole remaining director, and each director so elected shall hold office until his successor is elected at an annual meeting of shareholders or at a special meeting called for that purpose. The shareholders may at any time elect a director to fill any vacancy not filled by the directors, and may elect the additional directors at the meeting at which an amendment of the By-Laws is voted authorizing an increase in the number of directors. A vacancy or vacancies shall be deemed to exist in case of the death, resignation or removal of any director, or if the shareholders shall increase the authorized number of directors but shall fail at the meeting at which such increase is authorized, or at an adjournment thereof, to elect the additional director so provided for, or in case the shareholders fail at any time to elect If the Board of Director-

"Further, because certain directors have resigned, the bylaws delegate the power to appoint interim directors to fill the vacancies in the remaining board directors (positions). This means that Cheryl may appoint directors for the remainder of the terms of the director's positions being filled." ~Josh Nelson B,B&K

# HISTORY OF YSPUC

- Yosemite Lakes Owners' Association vs. Hanover/Titan/SafeCo/YSPUC 1982.
- YLOA was awarded YSPUC in 1987 as ASSET.
- YLOA Board of Directors are the Shareholders of YSPUC.
- Use of Blackhawk Lake and Water Draw. YLOA still reserves the privilege to use Black Hawk for Recreational Purposes, but still investigating what happened to the water draw rights as defined in the 1987 settlement.
- For many years, YSPUC 'loaned' money to YLOA, not the other way around.
- In recent years, YLOA has been 'loaning' money to YSPUC because YSPUC has been operating at a loss for 9 out of the last 12 years.

The trencher has arrived! This morning, the Vermeer T755 trencher for the Operation Self Sufficiency plan to rebuild our crumbling water system rumbled into YLP on a semi-trailer. YSPUC Manager Ken Harrington and YLOA General Manager Bob Civello, along with other YSPUC employees took delivery of the 35-40 ton machine.

Harrington said utility employees will start training on its use right away, and it should begin service with the first trenching later in July. It will be used to create a deep trench down our streets so that new water main pipe can be laid to replace aging and leaking pipes.



HIGHLIGHTS FROM THE JAN. 17 YLOA & YSPUC BOARD MEETINGS

Among items acted upon and receiving major attention were these:

- After an extended discussion and member comment both pro and con, the YSPUC board approved on a 3-2 vote to have the general manager request that a private company conduct a household-income survey of YSPUC water system customers. The free survey would determine if YLP is eligible for \$5 million in state grant money to help fund the ongoing water pipeline project.
   Voting yes: Joel Greathouse, Bart Fortner and Denis Ciccarelli. Voting no: Veronica Longcor and Bryan Colbert.
- There was discussion about why trenches from recent pipeline installations on Titan Drive have not yet been paved over. YSPUC Manager Ken Harrington said the recent heavy rains have prevented any paving work because the ground is saturated with water and any asphalt applied before it dries would sink. General Manager Layton Gillette said that crews have done a great job of dealing with the issue. Properties in that area are accessible and crews are continuing to maintain the roadway.
- There also was discussion about getting outside bids for the rest of the pipeline project, to check
  if the current course of construction using our own utility crews is the most cost-effective. YLOA
  President Bart Fortner ended by saying that bids already received before the project was started
  would be reviewed again before proceeding.

# WHY RECALL THE 24/25 YSPUC BOARD?

- Financial and Legal Concerns
- Not finding faster solutions on getting YSPUC Staff certified for Distribution and/or Treatment.
- First Resigned YSPUC President would not concede to selling the OSS/PRP equipment.
- Deficient Spending, "Get me the money, then leave me alone."
- More focused with "being on the board" than fulfilling Fiduciary Duties.
- Not focused on building the reserve, more focused on spending on new "projects."
- New YSPUC Attorney was never sent corporate Bylaws, Amendment or Articles of Incorporation until Cheryl Bluhm sent them to Josh Nelson with Best, Best and Krieger 12/13/2024 and 12/18/2024 along with the settlement "Blue Book" for legal review.
- The YSPUC Board created roadblocks for a YSPUC Director to get access to corporate records for over (60) days. (Corp. Code 1602 violation)

## DISCOVERIES - FINANCIALS

- Interfering with established accounting systems:
  - Releasing inaccurate financial statements without accounting signoff and before books were closed.
  - Delayed the payment of real estate property tax, incurring penalties and interest.
  - Delayed release of the YSPUC Reviewed Financial Statements fiscal years ended June 30, 2022, and June 30, 2023.
  - Delayed release of the 2023 annual financial report to the Public Utilities Commission.
- Incomplete & missing reports in Company Tariff Book and consequent failure to file PUC December 31, 2024, CPI increase for 2025 rate increase.
- Hiring a second bookkeeper to document procedures and make recommendations, with instructions to proceed without conferring with the current bookkeeper. Resulting in the same procedure recommendations by original bookkeeper.
- Duplication of efforts with outside CPA firm creating cost overruns.
- Attempt to change current accounting positions through robust calls to CPA and bookkeeper.
- Ignoring accounting request to ensure compliancy requests.
- Creating excess bookkeeping follow through due to many monthly penalties and late fees for bills not paid timely. \$4,886.58 in unnecessary late charges and interest fees since 7/1/2024.
- DMV registration not paid timely which incurred late charges.
- Overbilling and Large Adjustments without notification and approval of all YSPUC Directors.
- Reversed decision to raise rent on current tenant.
- Withholding YLOA Administrative Services Payment for services provided for YSPUC.



## REPORTING

#### QUESTIONS TO CSWB AND ANSWERS FROM CSWB

O: Operations Plan has not updated since 2007.

A: Correct, unless there is a hard copy in the file room or on old assigned staff computers.

O: Cross-Connection Control Guidance Plan has not updated since 2019.

A: Correct, updated or confirmed ever 5 years or if any major distribution changes have been madé.

Q: Emergency Plan has not updated since 2017.

A: Correct

Q: No Production Reports sent to CSWB since 2017.

A: monthly treatment reports have not, production report are to be submitted in the EAR which was completed. 2023 reporting is through the drought portal which is required to be inputted by the system monthly. Only a few months were reported in the 2023 EAR.

Q: The State Water Board stated that they had not received complete, accurate or any reporting since 2017 for required reporting.

A: Incorrect, at a quick glance that's what popped up, but I found some from in the server from 2019. Maybe hard copies in the file room.

#### REPORTING UPDATES

- 1. **LEAD Report**: Completed by Judy Quinn from the 23/24 YSPUC. Thank you, Judy!
- **2. Drought Reporting**: Mike Smith was helping with the completion of these reports, and then outside consultant Westside Water Resource started completing the reports at the beginning of July 2024 and continue to provide reporting services.
- 3. Monthly Production Reports/Well and Site Testing Results/Bat-T/Coli-Form Testing **Results**: Completed in house by administrative staff, Debbie.
- 4. End of Month Financial Reports to **Bookkeeper:** Completed in house monthly by administrative staff, Debbie.
- 5. Consumer Confident Report: Westside Water Resources helped in completing 2020 and 2023. Looking to have them complete 2024.

## DISCOVERIES - HUMAN RESOURCES

Directors failed to reach out to YSPUC professional HR Consultant and began making HR decisions on their own without involving the HR Professional, Ruth Evans.

Instead of using the HR Professional Consultant, they came to their own conclusions/determinations just by "reading" a website.

Failed to review HR protocols and read the YSPUC Employee Handbook to understand procedures.

Had inaccurate and biased conversations with our legal professionals.

Code of Ethics violations by Directors not being addressed by YSPUC Board President. (Neutering)

More concerned about the cost of the HR Consultant instead of the benefits of using the professional services.

Changed the previously created General Manager description, but then never advertised.
