



### **VACUUM BREAKERS**



Vacuum breakers are required on all household irrigation systems. Currently we are updating our cross connection and back flow prevention policy. YSPUC staff is working diligently to have our policy submitted to State Division of Drinking Water and approved by July 1, 2025. With spring gardening coming up this is a good time to examine your irrigation system to conform with our policy to ensure that the drinking water system is not accidentally contaminated with fertilizers and other greenhouse chemicals.

The YSPUC Board has been working very hard for the last several months to ensure that YSPUC has employed the most qualified, knowledgeable and certified staff to deliver safe drinking water to our customers. Starting with hiring Paul Stiglich as our General Manager and more recently, Michael Hightower and Colby Berger; we are moving in the right direction to have fully certified staff. Additionally, other YSPUC Utility Workers are working hard towards obtaining their required certifications.

As mentioned before, many required state agency reports were either not completed or were very out of date. Most recently we were contacted by the SWB that the State Water Board eAR (Annual Report) had never been completed. Paul is working on compiling all of the required information to complete this report. Another two required reports, the Risk and Resilience Assessment and Emergency Response Plan, were required to have been completed in 2021. Those were not completed by the deadline, so now YSPUC has contracted those reports to be completed to ensure we meet the necessary EPA requirements for drinking water utility companies. Our goals is to ensure that we are up to date with all reporting requirements with all State Agencies. All YSPUC Directors have been signed up for the AB 54 Ethics Training. Currently both Cheryl Bluhm and Joel Greathouse have obtained their certifications for this training which focused on topics like conflicts of interest, fiduciary duties, and Safe Drinking Water Act compliance.
